By Order entered in this cause on March 5, 2024, Motor Carrier Certificates F2470 and C3777 held by H & W Transfer & Storage, Inc., 920 Gadsden Road, Anniston, Alabama 36201 (P. O. Box 1084, Anniston, Alabama 36202), were revoked for failure to maintain proper proof of liability and cargo insurance coverage as required by law.
