REPORT AND ORDER

BY THE COMMISSION:

By application originally filed on or about August 20, 2024, and completed on September 6, 2024, Enterprise Rescue, Inc., 519 E. Lee Street, Enterprise, Alabama 36330, seeks authority to institute a new operation as a CONTRACT carrier by motor vehicle in intrastate commerce over IRREGULAR ROUTES in the transportation of: Passengers and their baggage between all points in the State of Alabama. In addition, Applicant seeks to extend an existing operation under Motor Carrier Certificate of Public Convenience and Necessity 4136 as a common carrier by motor vehicle, in intrastate commerce over IRREGULAR ROUTES in the transportation of: Passengers and their baggage between all points in the State of Alabama. The Applicant currently holds Certificate 4136 which authorizes the transportation of passengers and their baggage between all points and places in Crenshaw, Pike, Barbour, Covington, Coffee, Dale, Geneva and Houston Counties with a restriction against originating service in Houston County.

Pursuant to notice dated September 9, 2024, the application was set for hearing and heard on September 24, 2024. No notice of intention to protest was filed and no one appeared at the hearing in opposition to the application. The application, therefore, went forward unopposed. The Applicant waived its right to the issuance of a Report and Recommended Order in this cause.

It appears from the record in this proceeding, and we find, that the Applicant is fit, willing and able to properly perform the service proposed and to conform with the provisions of the Alabama Motor Carrier Act and the Commission's Motor Carrier Rules and that the proposed common carrier service is required by the public convenience and necessity and the proposed contract carrier service is consistent with the public interest.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That Motor Carrier Permit Number 658 is hereby issued to Enterprise Rescue, Inc., 519 E. Lee Street, Enterprise, Alabama 36330, authorizing operations as a CONTRACT CARRIER by motor vehicle in intrastate commerce over IRREGULAR ROUTES in the transportation of: Passengers and their baggage between all points in the State of Alabama, and Motor Carrier Certificate of Public Convenience and Necessity 4136 is hereby reissued to Enterprise Rescue, Inc., 519 E. Lee Street, Enterprise, Alabama 36330, authorizing operations as a COMMON CARRIER by motor vehicle, in intrastate commerce over IRREGULAR ROUTES in the transportation of: Passengers and their baggage between all points in the State of Alabama.

IT IS FURTHER ORDERED BY THE COMMISSION, That the operations herein authorized may be commenced only after the Applicant has filed with this Commission evidence of liability insurance and a tariff, and its schedule of rates as required by the rules and regulations of this Commission and has obtained registration numbers and properly identified its vehicles as required by the rules and regulations of this Commission. Unless the Applicant complies with these requirements within ninety (90) days after the date of this Order, or within such additional time as may be authorized by the Commission, the grant of authority made in this Order shall be considered as null and void and the application shall stand denied in its entirety effective upon the expiration of said compliance time.

IT IS FURTHER ORDERED BY THE COMMISSION, That the operations herein authorized shall be subject to all the rights, privileges, and immunities as well as all the restrictions, liabilities and responsibilities that are now or may hereafter be imposed by law or the rules and regulations of this Commission upon common and contract carriers by motor vehicle.

IT IS FURTHER ORDERED, That this Order shall be effective as of the date hereof.
