## <u>ORDER</u>

#### **BY THE COMMISSION:**

By application filed on or about September 26, 2018, Rogers Trucking LLC, 71 Private Road 1327, Ariton, Alabama 36311 and Johnny Ray Rogers d/b/a Rogers Trucking, 71 Private Road 1327, Ariton, Alabama 36311, seek authority from the Commission to transfer Motor Carrier Certificate of Public Convenience and Necessity F5042 from the latter to the former.

Pursuant to notice dated October 10, 2018, the Commission notified all interested parties that this cause was pending before the Commission and that unless request for public hearing was received on this matter on or before October 22, 2018, the same would be disposed of without a public hearing. No request for public hearing was received on or before October 22, 2018, and none has been received since that time.

A search of Commission records reveals that the authority under Certificate F5042 was due to be revoked by Commission Order entered in Informal Docket C-19250, on October 2, 2018, due to the Transferor's failure to maintain proper proof of liability insurance coverage. Further, by Commission Order dated October 29, 2018, the effective date of the Order of Revocation entered on October 2, 2018, was extended to and through November 30, 2018, in order for Johnny Ray Rogers d/b/a Rogers Trucking to transfer Motor Carrier Certificate F5042. It appears, therefore, that the Order entered in Informal Docket C-19250, on October 2, 2018, revoking

Certificate F5042, is due to be vacated and Certificate F5042 is due to be reinstated for the sole purpose of transferring Certificate F5042 in good standing.

It appears from the record in this cause, and we find, that the proposed Transferee is in all respects qualified under the applicable provisions of law to conduct the services contemplated under Certificate F5042, and that the proposed transfer is required by the public convenience and necessity.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That the Order entered in Informal Docket C-19250 on October 2, 2018, revoking Motor Carrier Certificate of Public Convenience and Necessity F5042 is hereby vacated, and Motor Carrier Certificate of Public Convenience and Necessity F5042 is hereby reinstated for the sole purpose of transfer only.

IT IS FURTHER ORDERED BY THE COMMISSION, That Motor Carrier Certificate of Public Convenience and Necessity F5042, heretofore issued by the Commission and now standing in the name of Johnny Ray Rogers d/b/a Rogers Trucking, 71 Private Road 1327, Ariton, Alabama 36311, is hereby transferred to Rogers Trucking LLC, 71 Private Road 1327, Ariton, Alabama 36311, authorizing operations as a common carrier by motor vehicle in the intrastate transportation of:

Property, except household goods, between all points in the State of Alabama.

IT IS FURTHER ORDERED BY THE COMMISSION, That the operations herein authorized may be commenced only after the Transferee has filed with this Commission evidence of liability and cargo insurance coverage as required by the rules and regulations of this Commission, and has obtained registration numbers and properly identified its vehicles as required by the rules and regulations of this Commission. Unless the Transferee complies with these requirements within 90 days after the date of this Order, or within such additional time as may be authorized by the Commission, the grant of authority made in this Order shall be considered as null and void and the application shall stand denied in its entirety effective upon the expiration of said compliance time.

IT IS FURTHER ORDERED BY THE COMMISSION, That the operations herein authorized shall be subject to all the rights, privileges and immunities as well as all the restrictions, liabilities and responsibilities that are now or may hereafter be imposed by law, or the rules and regulations of this Commission upon common carriers by motor vehicle.
