ORDER

BY THE COMMISSION:

By Petition filed on or about May 4, 2026, Hillard Wright d/b/a Kings Airport Shuttle Service, 976 S. Perry Street, Montgomery, Alabama 36104 (4450 Lawnwood Drive, Montgomery, Alabama 36108), requests that the Commission revoke and cancel its Motor Carrier Certificate FNP A-111. Hillard Wright d/b/a Kings Airport Shuttle Service maintains in its Petition that it no longer wishes to conduct operations under this authority.

It appears that the request of Hillard Wright d/b/a Kings Airport Shuttle Service is due to be granted and an order canceling Certificate FNP A-111 should be entered. Said Order will allow Hillard Wright d/b/a Kings Airport Shuttle Service to abandon operations consistent with Code of Alabama, 1975, §37 3 12.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That Motor Carrier Certificate FNP A-111, now standing in the name of Hillard Wright d/b/a Kings Airport Shuttle Service, 976 S.
