By our letter to you of October 9, 2012, which was acknowledged by letter of Judge John Garner in his letter of October 15, 2012, we notified the Commission of the impending change of control of Contact Network, Inc. d/b/a InLine ("InLine") to PEG Bandwidth, LLC ("PEG").

This is to confirm that on July 31, 2013, the approved transaction closed and InLine is now a wholly owned subsidiary of PEG. In addition, subsequent to the closing that Contact Network, Inc. converted to a limited liability company under Alabama law. The change to Contact Network, LLC was registered with the Secretary of State of Alabama on August 1, 2013, a copy of which is attached hereto. The company will file amendments to its tariff to reflect this conversion.
