**ORDER**

**BY THE COMMISSION:**

By Petition filed on or about November 15, 2019, Elbert A. Phillips Jr. d/b/a Britton 24 Hour Towing ("Britton 24 Hour Towing"), 14201 B Highway 231-431 N., (P. O. Box 742), Hazel Green, Alabama 35750, requests that the Commission revoke and cancel its Motor Carrier Certificate F4608. Britton 24 Hour Towing maintains in its Petition that it no longer wishes to conduct operations under this authority.

A search of the Commission's records reveals that the authority under Certificate F4608 was revoked by Commission Order dated November 5, 2019, in Informal Docket C-19581, due to Britton 24 Hour Towing's failure to maintain proper proof of liability and cargo insurance coverage. It appears, therefore, that the November 5, 2019, Order of Revocation entered in Informal Docket C-19581 is due to be vacated and Certificate F4608 is due to be reinstated for the sole purpose of cancelling Certificate F4608 in good standing. It further appears that the request of Britton 24 Hour Towing is due to be granted and an order cancelling Certificate F4608 should be entered. Said Order will allow Britton 24 Hour Towing to abandon operations consistent with *Code of Alabama*, 1975, §37-3-12.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That the Order entered in this cause on November 5, 2019, in Informal Docket C-19581 revoking Certificate F4608 is hereby vacated and

Certificate F4608 is hereby reinstated for the sole purpose of cancelling Certificate F4608 in good standing.

IT IS FURTHER ORDERED BY THE COMMISSION, That Motor Carrier Certificate F4608 now standing in the name of Elbert A. Phillips Jr. d/b/a Britton 24 Hour Towing, and the same is, hereby, revoked and cancelled.<sup>1</sup>


IT IS FURTHER ORDERED BY THE COMMISSION, That this Order shall be effective as of the date hereof.




