BY THE COMMISSION:

By Petition filed on or about January 26, 2026, Stephanie McJunkins d/b/a Junkins Transportation, 45 New Castle Drive, Phenix City, Alabama 36870, requests that the Commission revoke and cancel its Motor Carrier Certificate FNP B-116. Stephanie McJunkins d/b/a Junkins Transportation maintains in its Petition that it no longer wishes to conduct operations under this authority.
