REPORT AND ORDER

BY THE COMMISSION:

By application filed on April 28, 2026, Blue Stream Communications, LLC d/b/a Blue Stream Fiber, 12409 NW 35th Street, Coral Springs, Florida 33065, seeks a Certificate of Public Convenience and Necessity to provide telecommunications services in the State of Alabama.

Pursuant to notice dated May 11, 2026, the application was heard on June 15, 2026. The Applicant's Executive Vice President and General Counsel, Julie Plowman, testified at the hearing. Members of the Commission Staff also participated in the hearing. There were no intervenors.

It appears from the record in this proceeding, and we find, that the Applicant has demonstrated that it possesses the technical, managerial, and financial resources to provide the services proposed. Accordingly, it appears that the Applicant should be granted a certificate authorizing the provision of facilities-based and resold telecommunications services, including local exchange, exchange access, and interexchange services, consistent with the services similarly situated applicants have been authorized to provide.

The services authorized herein must be provided in compliance with the rules, regulations, and orders governing such service established by the Commission. To the extent the Applicant offers services requiring execution of an interconnection agreement under state or federal law, it shall submit such agreement for Commission approval. Failure to comply with this requirement shall result in the termination of the authority granted herein.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, that a Certificate of Public Convenience and Necessity is hereby issued to Blue Stream Communications, LLC d/b/a Blue Stream Fiber, 12409 NW

35th Street, Coral Springs, Florida 33065, authorizing operations as a provider of facilities-based and resold telecommunications services, including local exchange, exchange access, and interexchange services, in all areas of the State of Alabama.

IT IS FURTHER ORDERED BY THE COMMISSION, that the Applicant shall file annual reports and shall maintain adequate books of account and financial records in accordance with the rules and regulations promulgated by this Commission.

IT IS FURTHER ORDERED BY THE COMMISSION, that any changes, including name, address, telephone number(s), contact personnel, or other pertinent information concerning the Applicant, shall be filed with this Commission by written transmittal letter within thirty (30) days of such change.

IT IS FURTHER ORDERED BY THE COMMISSION, that the Applicant shall render sufficient and continuous service in accordance with the rules and regulations of the Commission and the Certificate of Public Convenience and Necessity issued herein.

IT IS FURTHER ORDERED BY THE COMMISSION, that the certificate granted herein will expire in one (1) year if the Applicant has not, submitted for Commission approval an interconnection/resale contract or agreement for local service and a final tariff governing such service.

IT IS FURTHER ORDERED, that jurisdiction in this cause is retained for the issuance of any further order or orders as this Commission may find just and reasonable.

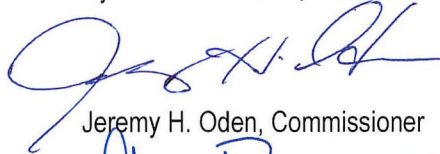
IT IS FURTHER ORDERED, That this Order shall be effective as of the date hereof.
