BY THE COMMISSION:

By application filed on or about April 6, 2026, Darlene Clifton Reddix d/b/a Unique Touch Transportation Services, 301 N Lafayette Street, Mobile, Alabama 36603, sought to institute a new operation as a common carrier over regular routes in the intrastate transportation of passengers and their baggage between all points in Mobile County.

Pursuant to notice dated May 7, 2026, the application was set for hearing on May 27, 2026. By Petition filed on or about May 21, 2026, Darlene Clifton Reddix d/b/a Unique Touch Transportation Services notified the Commission it wished to withdraw its application and the scheduled hearing was subsequently cancelled. It appears this Petition is reasonable and is due to be granted. It further appears, and we find, that the application is due to be dismissed.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That the Petition to withdraw the application of Darlene Clifton Reddix d/b/a Unique Touch Transportation Services is hereby granted.

IT IS FURTHER ORDERED BY THE COMMISSION, That the application of Darlene Clifton Reddix d/b/a Unique Touch Transportation Services is hereby dismissed.¹


