**CERTIFICATE CB115** 

#### **ORDER**

#### BY THE COMMISSION:

By Petition filed on or about October 15, 2024, Tammie G. & Edward L. Chism d/b/a Crown Charter Services ("Crown Charter Services"), 521 30<sup>th</sup> Avenue, Northport, Alabama 35476, requests that the Commission revoke and cancel its Motor Carrier Certificate CB115. Crown Charter Services maintains in its Petition that it no longer wishes to conduct operations under this authority.

A search of the Commission's records reveals that the authority under Certificate CB115 was revoked by Commission Order dated October 1, 2024, in Informal Docket C-21060, due to Crown Charter Service's failure to maintain proper proof of liability insurance coverage. It appears, therefore, that the October 1, 2024, Order of Revocation entered in Informal Docket C-21060 is due to be vacated and Certificate CB115 is due to be reinstated for the sole purpose of cancelling Certificate CB115 in good standing. It further appears that the request of Crown Charter Services is due to be granted and an order cancelling Certificate CB115 should be entered. Said Order will allow Crown Charter Services to abandon operations consistent with *Code of Alabama*, 1975, §37-3-12.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That the Order entered in this cause on October 1, 2024, in Informal Docket C-21060 revoking Certificate CB115 is hereby vacated and Certificate CB115 is hereby reinstated for the sole purpose of cancelling Certificate CB115 in good standing.

## DOCKET 31476 and INFORMAL DOCKET C-21060 - #2

IT IS FURTHER ORDERED BY THE COMMISSION, That Motor Carrier Certificate CB115 now standing in the name of Tammie G, & Edward L. Chism d/b/a Crown Charter Services, and the same are, hereby, revoked and cancelled.<sup>1</sup>

IT IS FURTHER ORDERED BY THE COMMISSION, That this Order shall be effective as of the date hereof.
