ORDER

BY THE COMMISSION:

Due to a scrivener's error in the Transferee's company name, this order takes the place of and is substituted for the February 9, 2012, Order entered in the above-referenced docket. All remaining parts of the original order are unchanged.

By application filed on or about January 12, 2012, Diana Cagle, d/b/a D & D Trucking Co., 2090 County Road 599, Hanceville, Alabama 35077, and Delano Cagle and Diana Cagle, d/b/a D & D Trucking Company, 2090 County Road 599, Hanceville, Alabama 35077, seek authority from the Commission to transfer Motor Carrier Certificate of Public Convenience and Necessity 3471 from the latter to the former.

Pursuant to notice dated January 13, 2012, the Commission notified all interested parties that this cause was pending before the Commission and that unless request for public hearing was received on this matter on or before January 30, 2012, the same would be disposed of without a public hearing. No request for public hearing was received on or before January 30, 2012, and none has been received since that time.

It appears from the record in this cause, and we find, that the proposed Transferee is in all respects qualified under the applicable provisions of law to conduct the services contemplated under Certificate 3471, and that the proposed transfer is required by the public convenience and necessity.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That Motor Carrier Certificate of Public Convenience and Necessity 3471, heretofore issued by the Commission and now standing in the name of Delano

Cagle and Diana Cagle, d/b/a D & D Trucking Company, 2090 County Road 599, Hanceville, Alabama 35077, is hereby transferred to Diana Cagle, d/b/a D & D Trucking Co., 2090 County Road 599, Hanceville, Alabama 35077, authorizing operations as a common carrier by motor vehicle in the intrastate transportation of:

Parts and accessories for trailers from Cullman and Montgomery, Alabama, to Elba, Alabama; porch swing chains from Vinemont, Alabama, to Selma, Alabama.


IT IS FURTHER ORDERED BY THE COMMISSION, That the operations herein authorized may be commenced only after the Transferee has filed with this Commission evidence of liability and cargo insurance coverage as required by the rules and regulations of this Commission, and has obtained registration numbers and properly identified its vehicles as required by the rules and regulations of this Commission. Unless the Transferee complies with these requirements within 90 days after the date of this Order, or within such additional time as may be authorized by the Commission, the grant of authority made in this Order shall be considered as null and void and the application shall stand denied in its entirety effective upon the expiration of said compliance time.




