## REPORT AND ORDER

BY THE COMMISSION:

By application filed on or about April 18, 2019, Innovative Transport & Logistics Solutions LLC d/b/a ITL Solutions ("ITL Solutions"), 315 South A Street, Pensacola, Florida 32502, sought authority to institute a new operation as a common carrier by motor vehicle in intrastate commerce over irregular routes in the transportation of passengers between all points in the counties of Jefferson, Washington, Mobile, Clarke, Baldwin, Monroe, Conecuh, Escambia, Butler, Crenshaw, Covington, Bullock, Pike, Barbour, Coffee, Dale, Henry, Geneva, and Houston.

Pursuant to notice dated May 6, 2019, the application of ITL Solutions was set for hearing and heard on May 23, 2019. The Commission received a notice of protest in this matter from Dothan Ambulance Service, Inc. Dothan Ambulance Service, Inc. appeared at the hearing on May 23, 2019, to further their protest.

A Report and Recommended Order summarizing the testimony in the proceeding and presenting the Hearing Officer's recommendation was served on the parties on June 25, 2019. The Hearing Officer recommended a denial of the authority. Because no Exceptions to the Report and Recommended Order were filed within twenty (20) days, the application was, by operation of the provisions of §37-3-9, *Code of Alabama*, 1975, automatically denied as recommended and set forth in the Report and Recommended Order.
