Pursuant to Rule T-13 of the Alabama Public Service Commission, Docket 15957, STi Prepaid, LLC ("STi"), a certificated telecommunications company operating in the State of Alabama pursuant to Docket No. 30390 effective July 31, 2007, and Vivaro Corporation ("Vivaro") (together with STi the "Parties") hereby notify the Commission that the Parties entered into an agreement and plan of merger whereby STi merged into Vivaro Acquisition LLC, a wholly-owned subsidiary of Vivaro, with STi remaining as the surviving entity (the "Transaction"). The Parties report the following:

- (1) As a result the Transaction, Vivaro will acquire all membership interests in STi and will pay the existing members of STi certain merger consideration in form of cash. Following the Transaction, STi will operate under the control of Vivaro and will continue to provide intrastate telecommunications services in the State of Alabama. No changes are planned in the service provided by STi as the result of the transfer of control to Vivaro, and no assignment of STi's certificates, assets or customers will occur as a result of the Transaction.
