### **ORDER OF SUSPENSION**

#### **BY THE COMMISSION:**

By filing received August 25, 2017, with a requested effective date of December 1, 2017, Petitioner Integrated Wastewater Management, Inc. ("IWM") petitioned this Commission for approval of revisions to its existing Tariff as set out herein.

#### **SEWER SERVICE TARIFFS AND RATES**

##### **Sewer Service Rates – Original Sheets 1 thru 29**

The proposed tariff revisions increase the wastewater rates for Alabama residential, condominium, and sewer collection and disposal only customers. The filing requests approval for the establishment of rates for recreational vehicle and vacant lot customers. In addition, IWM requests approval to implement a fee for equipment inspection when there is an ownership change and a fine for unauthorized customer tampering with any of the ME's lock out valves.

The Commission is of the opinion and finds that the proposed tariff revision requires study and further investigation to determine whether or not same are in the public interest, and therefore, that this filing should be suspended for a period of up to one hundred and eighty (180) days from the requested effective date to and through May 30, 2018.

**IT IS, THEREFORE, ORDERED BY THE COMMISSION,** That Petitioner Integrated Wastewater Management, Inc.'s proposed tariff revisions, as set out herein, is hereby suspended for a period of up to one hundred and eighty (180) days from the requested effective date to and through May 30, 2018.

IT IS FURTHER ORDERED BY THE COMMISSION, That this Order shall be effective as of the date hereof.
