BY THE COMMISSION:

By application originally filed on or about November 21, 2025, Rivers Ridge Moving and Labor LLC d/b/a Rivers Ridge Moving and Labor (“Rivers Ridge Moving and Labor”), 3440 Valley Avenue SW, Unit B, Decatur, Alabama 35603, seeks authority to transport household goods between all points in the State of Alabama.

It appears from the application and the materials filed with it that the Applicant is fit, willing and able to properly perform the service proposed and to conform with the provisions of the Alabama Motor Carrier Act. It also appears that the Applicant’s proposed tariff is just and reasonable.

IT IS FURTHER ORDERED BY THE COMMISSION, That the tariff filing is hereby approved.

IT IS FURTHER ORDERED BY THE COMMISSION, That the operations herein authorized shall be subject to all the rights, privileges and immunities as well as all the restrictions, liabilities and


