## **ORDER OF CANCELLATION**

## **BY THE COMMISSION:**

By Order dated September 15, 1998, under Docket Number 26559, Legacy Long Distance, Inc. d/b/a Legacy Inmate Communication was granted a Certificate of Public Convenience and Necessity to provide Toll Reseller Telecommunications Service in the State of Alabama. By Order dated May 4, 2010, under Docket Number U-4968, Legacy Long Distance, Inc. d/b/a Legacy Inmate Communication was granted a Certificate of Public Convenience and Necessity to provide Inmate Phone Services in the State of Alabama. By Order dated November 3, 2014, under Docket Number U-5134, Legacy Long Distance, Inc. d/b/a Legacy Inmate Communication was granted a Certificate of Public Convenience and Necessity to provide Customer-Owned, Coin-Operated Telephone Service in the State of Alabama. By notice to this Commission dated September 1, 2020, Legacy Long Distance, Inc. d/b/a Legacy Inmate Communication transferred its Alabama customer base to Network Communications International Corp. d/b/a NCIC Inmate Communications. As of December 1, 2020, Legacy Long Distance, Inc. d/b/a Legacy Inmate Communication is no longer providing telecommunications service in the State of Alabama and requests cancellation of its Certificates of Public Convenience and Necessity and withdrawal of its tariffs.

Upon review, it appears that the request of Legacy Long Distance, Inc. d/b/a Legacy Inmate Communication for cancellation of its Certificates of Public Convenience and Necessity is due to be granted.
