<u>ORDER</u>

BY THE COMMISSION:

By Petition filed on or about April 13, 2022, S & D Trucking, LLC ("S & D Trucking"), 4224 Aberdeen Road, Vernon, Alabama 35592 (P.O. Box 1003, Vernon, Alabama 35593), requests that the Commission revoke and cancel its Motor Carrier Certificate F4002. S & D Trucking maintains in its Petition that it no longer wishes to conduct operations under this authority.

A search of the Commission's records reveals that the authority under Certificate F4002 was revoked by Commission Order dated April 5, 2022, in Informal Docket C-20271, due to S & D Trucking's failure to maintain proper proof of cargo and liability insurance coverage. It appears, therefore, that the April 5, 2022, Order of Revocation entered in Informal Docket C-20271 is due to be vacated and Certificate F4002 is due to be reinstated for the sole purpose of cancelling Certificate F4002 in good standing. It further appears that the request of S & D Trucking is due to be granted and an order cancelling Certificate F4002 should be entered. Said Order will allow S & D Trucking to abandon operations consistent with *Code of Alabama*, 1975, §37-3-12.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That the Order entered in this cause on April 4, 2022, in Informal Docket C-20271 revoking Certificate F4002 is hereby vacated and Certificate F4002 is hereby reinstated for the sole purpose of cancelling Certificate F4002 in good standing.

IT IS FURTHER ORDERED BY THE COMMISSION, That Motor Carrier Certificate F4002 now standing in the name of S & D Trucking, LLC, and the same are, hereby, revoked and cancelled.¹
