**BY THE COMMISSION:**

By Petition filed on or about April 13, 2022, Dirk Mims Trucking Company, Inc., 697 County Road 428, Clanton, Alabama 35045 (P. O. Box 1735, Clanton, Alabama 35046), requests that the Commission revoke and cancel its Motor Carrier Certificate F4035. Dirk Mims Trucking Company, Inc. maintains in its Petition that it no longer wishes to conduct operations under this authority.

It appears that the request of Dirk Mims Trucking Company, Inc. is due to be granted and an order canceling Certificate F4035 should be entered. Said Order will allow Dirk Mims Trucking Company, Inc. to abandon operations consistent with *Code of Alabama*, 1975, §37-3-12.<sup>1</sup>




IT IS FURTHER ORDERED BY THE COMMISSION, That this Order shall be effective as of the date hereof.


