ORDER

BY THE COMMISSION:

By Order entered in this cause on December 4, 2018, Motor Carrier Certificate F4122 held by John T. Beard d/b/a JTB Contractor, 1404 County Road 345, Decatur, Alabama 35603, was due to be revoked for failure to maintain proper proof of liability and cargo insurance coverage as required by law.

On or about December 17, 2018, the Petitioner submitted a petition for the approval of cargo self-insurance, which was approved by the Commission on January 8, 2019. Also, on or about December 19, 2018, the Petitioner submitted documentation that the liability insurance coverage required by law had been maintained in full force and effect continuously, but proper proof of such coverage did not reach the Commission due an error by the insurer in submitting the required Form E. Accordingly, the Petitioner requested reinstatement of its authority.

By Order entered in this cause on December 20, 2018, the effective date of the Order of Revocation issued on December 4, 2018, was extended to and through January 31, 2019. As the Petitioner has satisfactorily demonstrated that the required liability insurance coverage has been properly maintained; presented the Form E demonstrating such coverage within the extension of time granted by the Commission; and received self-insurer approval, it appears that the Order entered in this cause on December 4, 2018, revoking Certificate F4122 is due to be vacated and Certificate F4122 is due to be reinstated.
