**ORDER**

**BY THE COMMISSION:**

By Petition filed on or about September 12, 2019, WHC AL, LLC d/b/a zTrip ("zTrip"), 3024 Airport Blvd., Mobile, Alabama 36606, requests that the Commission revoke and cancel its Motor Carrier Certificates 3223, 2613 and F326 and reinstate Motor Carrier Certificates 726 and 3104. Motor Carrier Certificates 3104, 726, 2613, 3223, and F326 were revoked by Commission Order dated August 13, 2019, due to zTrip's failure to make the required filings. The Petitioner has now made the required filings with respect to Motor Carrier Certificates 726 and 3104.

It appears, therefore, that the August 13, 2019, Order of Revocation entered in Docket 32889 is due to be vacated and Certificates 3223, 2613 and F326 are due to be reinstated for the sole purpose of cancelling Certificates 3223, 2613 and F326 in good standing. It further appears that the request of zTrip is due to be granted and an order cancelling Certificates 3223, 2613 and F326 should be entered. Said Order will allow zTrip to abandon operations consistent with *Code of Alabama*, 1975, §37-3-12.

It further appears that the Petitioner has made the required filings with respect to Motor Carrier Certificates 726 and 3104 and that Certificates 726 and 3104 are due to be reinstated.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That the Order entered in this cause on August 13, 2019, in Docket 32889 is hereby vacated and Certificates 3223, 2613 and F326 are hereby reinstated for the sole purpose of cancelling Certificates 3223, 2613 and F326 in good standing.




IT IS FURTHER ORDERED BY THE COMMISSION, That Certificates 726 and 3106 are, hereby, reinstated.


