SIERRA CLUB'S MOTION FOR LEAVE TO ANSWER AND ANSWER TO ALABAMA POWER COMPANY'S RESPONSE TO SIERRA CLUB'S PETITION FOR RECONSIDERATION AND REHEARING

Sierra Club hereby moves for leave to answer¹ and answers one issue in Alabama Power Company's response to Sierra Club's petition for reconsideration and rehearing. The issue is the timeliness of Sierra Club's petition. Such petitions may be filed "any time after an order has been made by the Commission," under section 37-1-105, Code of Alabama.² Alabama Power urges the Commission to nonetheless strike Sierra Club's petition as an "untimely filing." But as explained below there is no basis in law or fact to do so.

- 1. The Commission issued its order approving Alabama Power's petition for a certificate of convenience on August 14, 2020.
- 2. Sierra Club electronically filed its petition for reconsideration and rehearing on September 14, 2020. The Office of the Commission Secretary accepted the filing and the acceptance is attached as exhibit A. It states: "Internet filing submitted on 9/14/20 is accepted."
- 3. Sierra Club also delivered the original and one copy at approximately noon the next day, September 15, 2020. The Office of the Commission Secretary approved by stamping them as received that day, and a copy of the stamped first page is enclosed as exhibit B.
 - 4. In its response, Alabama Power ignores the plain language of section 37-1-105

that a petition for rehearing may be filed "any time" after the Commission makes its order.⁴ Alabama Power relies instead on Commission rules that on their face do not establish its reasoning that Sierra Club's filing was untimely.⁵

- 5. Specifically, the Company relies on Rules 7(a) and 21(c) of the Commission's Rules of Practice. But Rule 7(a) merely states when "the Offices of the Commission" are "open for the transaction of business." Likewise, Rule 21(c) merely states that petitions for rehearing "must be filed within thirty (30) days from the date of the final action on the matter for which rehearing or reconsideration is sought, unless an extension is granted by the Commission." Neither rule even mentions electronic filing, much less prescribes the requirements for accomplishing such filing in a timely manner, as relevant here.
- 6. Indeed, as the Commission recently affirmed, entirely different, "temporary" rules adopted in 2005 "have governed the electronic filing of documents since that time." Those rules provide in pertinent part as follows:

Any document filed electronically with the Commission via the Internet is deemed to be received by the Commission when it is

received in the PSC Tracking Database as long as the original document and a copy are received by the Commission by 5 p.m. on the next business day. . . . ¹⁰

7. As applied here, Sierra Club's indisputably filed its petition on time, on September 14, within 30 days of Commission's August 14 order, which is the final action for which Sierra Club seeks rehearing and reconsideration. The relevant facts are established in exhibits A and B: the Office of the Commission Secretary accepted Sierra Club's electronic filing as "submitted" on September 14, and approved receipt of the original the next day. Neither Alabama Power nor its counsel is empowered to overrule that Office's acceptance and approval of a timely filed pleading.

Wherefore Sierra Club respectfully requests the entry of an order accepting this answer and averring the timeliness of Sierra Club's petition for rehearing and reconsideration.
