Petition: For review of Energy Supply Agreement pursuant to provisions of Section 11-50A-25, Code of Alabama 1975, as amended.

ORDER

BY THE COMMISSION:

On November 13, 2025, pursuant to the provisions of Section 11-50A-25, *Code of Alabama 1975*, as amended, the Petitioner, Alabama Municipal Electric Authority (the "Authority"), filed with the Alabama Public Service Commission (the "Commission") an Energy Supply Agreement (the "Energy Supply Agreement") providing for the sale by Alabama Power Company of wholesale electric power to the Authority which shall be resold to the Utilities Board of the City of Foley ("Riviera Utilities") pursuant to the Foley Solar Plant Rider FSP-2025 adopted by the Authority at the same rate as charged to the Authority under the Energy Supply Agreement for the ultimate sale of such electric power at retail to the Foley Solar Plant located within Riviera Utilities' service territory. The Authority has requested that the Commission review the Energy Supply Agreement pursuant to the provisions of Section 11-50A-25, *Code of Alabama 1975*, as amended, to determine if the rates to be charged by the Authority pursuant thereto are reasonable and in the public interest.

The Commission has given full consideration to the provisions of the Energy Supply Agreement and other information provided by the Authority with respect thereto. In addition, the Commission has considered the purpose for which the Authority is established, the provisions of Section 11-50A-18, *Code of Alabama 1975*, as amended, and the need to: (i) encourage conservation of energy supplied by the Authority, (ii) encourage the optimization of the efficiency of use of facilities and resources, and (iii) promote equitable rates to electric consumers. As a result of the foregoing and the evaluation and recommendation of our Staff, the Commission hereby finds the rates to be charged by the Authority pursuant to the Energy Supply Agreement to be reasonable and consistent with the public interest and,

therefore, should not be and are not disapproved by the Commission.

IT IS, THEREFORE, ORDERED BY THE COMMISSION, that the Agreement and the rates to be charged by the Authority pursuant to the provisions of the Energy Supply Agreement are not disapproved by the Commission.

IT IS FURTHER ORDERED BY THE COMMISSION that jurisdiction in this cause is hereby retained for any further order or orders that this Commission may find just and reasonable under the circumstances.

IT IS FURTHER ORDERED BY THE COMMISSION that this Order shall be effective as of the date hereof.
