This memorandum reflects activities of the Gas Pipeline Safety (GPS) Division that will be presented at the January 10, 2023, Commission Meeting.

➤ GPS performed the following inspections during the month of November, a total of seventy (70) inspections and two (2) operator training sessions were conducted utilizing eighty-nine (89) person-days. The inspections are itemized as follows:

From the seventy (70) inspections shown above, five (5) enforcement letters of notification were issued, noting sixteen (16) non-compliance issues. There were seven (7) non-compliance items corrected during the month of November.

#### **Incidents/Accidents**

One PHMSA reportable incident was reported during the month of November. There was one State reportable incident that was reported during the month of November. One in the central section and the other in the southern section. The PHMSA reportable had a fire, no explosion, or injuries occurred. The State reportable had no fire, explosion, or injuries occure.

- ➤ 11/16/2022 Spire Gulf Creola, AL A Contractor unloaded a piece of heavy equipment on the side of the road. The ground gave way due to rain and the equipment sank causing the equipment to come into contact with a 2" (PE) main at 1363 Creola Axis Loop, Creola, AL. The Main ruptured causing a fire that destroyed the heavy equipment. The repair and loss of the equipment looks to be above the 122,000 PHMSA reporting threshold.
- ➤ 11/23/2022 Spire Alabama Pike Road, AL Contractor struck a 6" (PE) main. At 53 Boykin Lakes Blvd, Pike Rd 36064. The contractor was installing a sewer main extension. There was no active locate ticket submitted by the contractor prior to excavation. Spire plans to submit a violation for the Alabama dig law.

Two (2) operator/contractor training sessions on Polyethylene (PE) plastic fusion were conducted during the month of November:

The total personnel trained was 68 (All operator personnel).

#### Miscellaneous

Received all comments for GPS Rule 15. Three reposnses in total were submit two by operators and one by ANGA which repsented close to 100 Operators. The comments asked for things GPS had anticpated. A final draft of the rule is still under development.

GPS has worked to ensure that all PHMSA required inspection are being performed within the required timeframes. All vaction time was frozen until a schedule could be presented showing the timeframes will be met.

The Common Equity as of November 30, 2022 (Actual) was adjusted using net income, payment of Common Stock and Preferred Stock dividends, Capital Contributions, and Other Adjustments from the Company's 2022 budget. The average common equity is a 12-month average using actual and budgeted data. The average retail common equity (RCE) was calculated using the retail separation factor of 95.06%. The retail net income (RNI) for average common equity and the common equity percentage (CEP) were calculated by using actual data for the eleven months ended November 30, 2022, and then adding one month of budget data for December 2022. The Other Adjustments, if any, are the result of the Company adopting FASB Statement 123 (R), which requires the reporting of stock option expenses.

The Forecast is subject to change due to uncertainties associated with weather, customer usage patterns and economic conditions across the state.

#### RAILWAY SAFETY

There were four incidents reported by the National Response Center (NRC) in November:

- 1. A vehicle strike resulted in unknown injuries in Birmingham on **NS**. This incident involved a loaded passenger train.
- 2. A trespasser strike resulting in a fatality in Garden City on CSX
- 3. A calcium oxide (lime) spill of unknown amounts was caused by a faulty railcar door in Sylacauga on NS
- 4. A vehicle strike resulted in unknown injuries in Birmingham on **NS**. This incident involved a loaded passenger train.

UED staff also hired a new track inspector that began on November 21. Mr. Conway was previously a Senior Track Supervisor with CSX in Birmingham. He brings with him a wealth of knowledge from the railway industry and is a welcomed addition to the RWS staff.

As of November 30, there were 11,133 Alabama carriers (83%) registered for 2022 UCR with 2,213 that remain unregistered. As of November 30, there were 4,308 Alabama carriers (35%) registered for 2023 UCR with 7,896 that remain unregistered.

During November, staff mailed nine pending payment letters to carriers that created a voucher several

weeks prior where payment had not been received for the 2023 UCR registration year and one for the 2022 UCR registration year.

The staff also assisted motor carriers in making necessary changes to their operating status with the Federal Motor Carrier Safety Administration (FMCSA). There were five MCS-150 forms processed indicating that two motor carriers' USDOT numbers were deactivated and three forms contained updates to carriers' USDOT number data.

MCS staff attended the UCR Audit Subcommittee call and the UCR Finance Subcommittee call both held in November.

The staff received five For Non-Profit (FNP) quarterly reports from FNP carriers for the third quarter of 2022.

There was one passenger supplement tariff for Unique Car Care, LLC (C3721) accepted in November.

Staff conducted an on-site visit in October that was resolved in November for S & M, L.L.C. d/b/a Huntsville Cab Company (C3871). The carrier was recommended to create a process to centralize and hold trip records at the main office of the business.
