No discount shall be applied for contracts under Rates BTA, XFOOD-M, FMTU, XGROC-M, XHCARE-L, XHCARE-M, XLODGE-L, XLODGE-M, LPLM, XLPTM, XLPTS, MTU, PMTU, PTU, XRETL-L, XRETL-M, SCGTU, SCH, and TXTU.

TERMINATION OF AGREEMENT FOR ELECTRIC SERVICE

The discounts described in the preceding section are provided in recognition of the Consumer's commitment to the five (5) year rolling term, which will enhance the Company's ability to match its plan for new generation to the needs of its customers.

The manner and consequence of termination of the Agreement for Electric Service shall be as follows:

- (1) If the Consumer complies with the five (5) year notice requirement for termination and continues to take and pay for service for such five (5) year term, the applicable discount for the remaining term of the Agreement will remain fixed at the percentage in effect upon receipt of notice of cancellation.
- (2) If the Consumer chooses to terminate the Agreement for Electric Service on less than five (5) years' notice, it may do so by: (i) giving at least one (1) year's written notice to the Company; and (ii) paying an amount equal to the monthly charge for billing capacity specified in the applicable rate (except for Rates XLPTL and RTP, which shall be equal to the monthly charge in Rate LPL) times the Consumer's contracted capacity for the remaining months at the time of notice of cancellation of the five (5) year rolling notice period together with recognition of the applicable discount in effect upon receipt of notice of cancellation. The payment described in (ii) above is due on or before the specified date of termination.
- (3) If the Consumer breaches the Agreement for Electric Service, it shall pay as liquidated damages, the amount set forth in item (2)(ii) above without recognition of the applicable discount, plus any attorneys' fees and court costs incurred by the Company and any outstanding billings due for service rendered.

Available in all areas served from the interconnected system of the Company.

APPLICABILITY

Applicable to any customer connected to the Company's system that has electric generating capacity installed and which desires the Company to furnish Supplementary, Back-up, and/or Maintenance Power to the premises.

DEFINITIONS

Supplementary Power -

Electric energy or capacity regularly used at the premises by a customer in addition to that which it ordinarily

generates on its own.

Back-up Power

Electric energy or capacity available to replace energy used at the premises and ordinarily generated by a

customer's own generation equipment during an

unscheduled outage.

Maintenance Power

Electric energy or capacity supplied for use on the

premises during scheduled outages of the customer's

BACK-UP POWER

Contract capacity and previous capacities will not be considered in calculating the capacity for billing purposes. The demand minimums for the applicable rate shall apply for billing purposes.
 - If the service is used less than one month, the capacity requirement established (KW or KVA) and kilowatt hours consumed during the service period will be projected to a full month and the appropriate rate applied; this amount will then be prorated for the number of days the service is used, but the proration will not be for less than two days.
