ORDER

BY THE COMMISSION:

By Petition filed on or about July 14, 2022, Central Alabama Transport, Inc. ("Central Alabama Transport"), 3010 Rice Mine Road, Tuscaloosa, Alabama 35406 (14716 Bel Aire Estates, Coker, Alabama 35452), requests that the Commission revoke and cancel its Motor Carrier Certificates F392 and P538. Central Alabama Transport maintains in its Petition that it no longer wishes to conduct operations under this authority.

It appears that the request of Central Alabama Transport is due to be granted and an order canceling Certificates F392 and P538 should be entered. Said Order will allow Central Alabama Transport to abandon operations consistent with *Code of Alabama*, 1975, §37-3-12.¹

IT IS, THEREFORE, ORDERED BY THE COMMISSION, That Motor Carrier Certificates F392 and P538 now standing in the name of Central Alabama Transport, Inc., 3010 Rice Mine Road, Tuscaloosa, Alabama 35406 (14716 Bel Aire Estates, Coker, Alabama 35452), be, and the same are, hereby, revoked and canceled.




