General Notes:

On November 17, 2009 (the "Confirmation Date"), the Bankruptcy Court entered an order (the "Confirmation Order") confirming the Debtors' Joint Plan of Reorganization, as amended, pursuant to chapter 11 of the Bankruptcy Code, which was originally filed with the Bankruptcy Court on the Petition Date and supplemented by the Supplement to Debtors' Joint Plan of Reorganization pursuant to chapter 11 of the Bankruptcy Code filed with the Bankruptcy Court on the Petition Date (as so amended and supplemented, the "Plan").

On November 30, 2009 (the "Effective Date"), the Debtors consummated their reorganization under the Bankruptcy Code and the Plan became effective. The distributions of securities under the Plan of the Debtors (the "Plan Effects") were made on the Effective Date.

In connection with the Plan, Charter Communications, Inc. ('Charter"), Charter Investment, Inc. ("CII"), Mr. Paul G. Allen and Charter Communications Holding Company entered into an exchange agreement, pursuant to which CII had the right to require Charter to merge CII with and into Charter. On February 8, 2010, the merger occurred. CII and any related transactions have been included in this report post the February 8, 2010 merger.

On June 17, 2010, the Bankruptcy Court granted final decree closing certain of the chapter 11 cases. Accordingly, the chapter 11 cases for all entities, except for Charter (case no. 09-11435), have been closed as of June 17, 2010. For the purposes of the 2nd quarter MOR, a June 30 2010 effective date was assumed.

The financial information contained herein is presented on a preliminary and unaudited basis and remains subject to future adjustment.

Notes to Attachment 1:

The Reorganized Debtors' believe that all undisputed post-confirmation accounts payable have been and are being paid in accordance with the Reorganized Debtors' terms and conditions.

Notes to Attachment 2:

The Schedule of Receipts and Disbursements is on a consolidated basis. Attachments 4 and 5 show total receipts and disbursements by individual Reorganized Debtor.

Notes to Attachment 3:
