



I, the undersigned, desiring to become a body corporate, do hereby file the following Articles of Incorporation, pursuant to the laws of the State of Alabama, and the undersigned incorporator does hereby make and subscribe her name to these Articles.

**ARTICLE I.**

**NAME**

The name of the corporation shall be: **ANNISTON LIMOUSINE, INC.**

**ARTICLE II.**

**OBJECTS**

The organization is organized for the purpose of carrying out and transacting all business which may lawfully be carried out and transacted by a corporation in the State of Alabama, including, but not limited to, the following enumerated objects: Either to own or operate buses, vans and other means of transportation of




