ORDER

BY THE COMMISSION:

Rule 700-X-10-.09 of the Commission's Motor Carrier General Orders, Rules and Regulations requires that each and every intrastate motor carrier subject to the jurisdiction of this Commission, unless otherwise exempted, file with the Commission an annual report covering the results of their operations for the related calendar year. Pursuant to Rule 700-X-10-.09, the annual report is due on April 30th of the year following the year to which the report relates. Further, Rule 700-X-10-.09 makes provisions for carriers having particular cases of unusual circumstances to request, in writing, an extension of time to file their annual report; and such extensions so requested were granted until July 31, 2026.

IT NOW APPEARING, That the intrastate motor carriers shown as Respondents on Appendix A herein have either: (1) failed to file annual reports for the calendar year 2025 by April 30, 2026, and without good cause appearing therefore, or (2) filed their 2025 Annual Reports, but said reports were returned to those carriers as unacceptable but the carriers did not resubmit an acceptable Annual Report as requested by the Commission, or (3) failed to file by the July 31, 2026, extension date.

IT IS THEREFORE ORDERED BY THE COMMISSION, That pursuant to the provisions of Section 37-3-7(8), Code of Alabama 1975, as amended, an investigation is hereby instituted to determine whether, in accordance with the provision of Section 37-3-16, Code, the operating authority of the carriers listed in Appendix A to this order should be suspended or revoked. Said carriers are hereby made Respondents to this proceeding.

IT IS FURTHER ORDERED BY THE COMMISSION, That each and every Respondent hereto is hereby directed and required to individually appear before the Commission in its RSA Union Building, 100 North Union Street, Suite 900, Montgomery, Alabama, at 9:00 a.m., on Tuesday, September 22, 2026, to then and there show cause why the operating authority in their certificate or permit, as the case may be, should not be suspended or revoked for failure to comply with the lawful rule of the Commission and its order herein.

IT IS FURTHER ORDERED BY THE COMMISSION, That all Respondents listed in Appendix A are hereby required and directed to present their annual report covering results of their operations for the year 2025 to this Commission at the above-scheduled hearing.

IT IS FURTHER ORDERED BY THE COMMISSION, That, in the event the provisions of the preceding paragraphs are not complied with as stated in this Order, the certificates of public convenience and necessity or permits, as the case may be, of the Respondent carriers will, on the following date stand revoked and thereafter said Respondents may not conduct intrastate service as motor carriers on the highways of the State of Alabama without first having sought and obtained proper authority from this Commission as required by law.

IT IS FURTHER ORDERED, That this Order shall be effective as of the date hereof.
