### **ORDER**

#### **BY THE COMMISSION:**

On December 26, 2024, AIBEK Inc (“AIBEK”), 345 Randy Road, Ashford, Alabama 36312, filed its Unified Carrier Registration (“UCR”) for the 2025 registration year and paid for 5 vehicles. However, records collected by Commission Staff show that AIBEK had 34 unique vehicle inspections as of June 2025 and 31 unique vehicle inspections during 2024. The discrepancy between the number of unique vehicle inspections and UCR registered vehicles indicates a possible UCR registration issue.

Pursuant to Ala. Code § 37-3-32.1, the Commission is the state agency responsible for the administration of the United Carrier Registration Act of 2005. Under this authority, through letters and emails dated March 6, 2025, May 25, 2025, and June 5, 2025, Commission Staff notified AIBEK to provide information to remedy the discrepancy between the UCR registration and the number of vehicle inspections. AIBEK did not respond to those letters or emails.

Because of AIBEK’s failure to adequately respond, the Commission issued an order on July 1, 2025, pursuant to Ala. Code § 37-3-7(8), that initiated an investigation to determine whether the UCR registration of AIBEK should be suspended. That order directed AIBEK to provide documentation and to appear at a hearing at the Commission on August 11, 2025, to demonstrate good cause why its UCR

registration should not be suspended. AIBEK failed to provide the documentation and did not appear at the hearing.

IT IS, THEREFORE, ORDERED BY THE COMMISSION that the Unified Carrier Registration for AIBEK Inc for all active years is hereby suspended.

IT IS FURTHER ORDERED that this Order shall be effective as of the date hereof.




